Special recognition should also go to Dr. Robert Elliott and to Dr. J. D. Larkin. We have a newsletter of which we can all be proud. I'm sure you've noticed the considerable amount of space in the newsletter devoted to Constitution and By-Laws changes. That resulted from the time consuming and exacting work of Dr. Elliott and his By-Laws Committee. Their work has been vital to the conduct of business of the College.

The College's Study Guide for Certification, which was the brainchild of the Education Committee, under Drs. Bob Sproull and Dean Johnson, has been in such great demand that it has already become a self supporting enterprise, something which we didn't ever particularly expect to happen.

I am also pleased to announce that Drs. Charles Kelsey and Brian Lang will soon have ready for publication a final report on the College's Survey of Income of Prosthodontists. We also have in operation two new Ad Hoc committees which should have great impact on the specialty, Dr. Gordon's Specialty Review Committee, and Dr. Koper's Committee on Aims and Goals.

I want to mention too, that this is the first business meeting where associate members are also voting members. Welcome, Associate Members, to your new and more responsible role in the College.

As I said at the beginning, this has indeed been a year of continuity and progress.

It seems, however, that problems always have a way of proliferating at a faster rate than solutions. Certainly this has been the case with prosthodontics. Because of this, I am convinced that the College needs to develop some additional mechanisms for individual members to have greater input toward our attack on pressing problems. One of the shortcomings of our operation this past year, and to some extent previous years, has been the lack of opportunity for our stand-

ing committees to be as active as they should be in College affairs.

In my opinion, plans and provisions should be made to permit our committee chairmen to hold working sessions of their committees during our annual sessions and perhaps also in conjunction with an interim executive council meeting at the time of the Chicago Midwinter Meeting.

Perhaps the committees should be expanded in size to utilize more of the talents of more of our members. We need to address ourselves more fully to such crucial issues as the difficulties specialists have in obtaining state board licensure after they have become specialists, and also the embryonic but growing movement toward periodic relicensure and even periodic recertification.

Issues of similar import will probably always be with us. Therefore, the College should look for ways to get its present committees and other interested members into productive work sessions at regular intervals. This would certainly bolster the efforts of the Executive Council in your behalf.

Gentlemen, I thank you for the privilege of serving as President of the College this past year. It has been at once a challenging and a gratifying experience.

I leave office with a feeling of great confidence in the future of the College. We have a truly dedicated membership, and we also have in President-elect Smith a man with the drive and ability to keep the College moving.

CHANGE II

Effective June 1974 (Supersedes Change I)

#### VI. CHANGE II TO BOARD INSTRUCTIONS

Completed applications are reviewed by the Board in February and in June each year and should be in the office of the Secretary of the American Board of Prosthodontics two months before either date.

The following changes in the policy information found in the current Informational Booklet published by the Board (revised version - 1972). The Booklet is being revised for publication in late 1974. The changes are in effect now.

- 1. The application fee for certification is \$50.00 and a check in this amount (U.S. currency) must accompany the application form. (See page 6 of current Booklet.)
- 2. The period of Board Eligibility (commencing with the acceptance and approval of an application and receipt of fee) is three (3) years and must be re-established by re-application if the candidate has not been examined during the three (3) year period. (See page 4 of current Booklet.
- 3. a. Upon submitting an application, to include evidence of the successful completion of an accredited program in advanced prosthodontics, a candidate for certification may become eligible for the Phase I, part 1 (written) examination immediately.
- b. To qualify for the Phase II examination, the applicant must have a minimum of five (5) years in the practice of prosthodontics, two (2) years of which may have been spent in graduate, residency, or post-graduate programs. The remaining three (3) years normally follow the two (2) years of advanced prosthodontic education. (see page 5, item 3 in the current Booklet...this information replaces the first sentence in item 3)
- 4. If clinical examination in maxillofacial prosthetics is elected by the candidate (Phase II, part 1), the proposed intra-oral treatment must be submitted in advance (at the Phase I meeting prior to Phase II) for Board approval. The candidate will furnish his own patient. (page 8, item 3)
- 5. Approved applications are valid for three (3) years. A new application must be submitted with re-payment of the application fee if the candidate has not appeared for examination within three (3) years.
- 6. Candidates failing Phase I, part 1 (written) or Phase II, part 2 (oral) will be permitted to repeat the examination failed in one year. (see page 9...Re-Examination)
