PRESIDENT'S MESSAGE

JOURNAL EXCHANGE SUGGESTED

ASSOCIATES TO RECEIVE CERTIFICATES

The balloting on the issue of whether or not associates should receive certificates was very close. 563 ballots were mailed to members and 421 of these were returned. Only 142 members did not return their ballots. 208 members voted against issuing certificates and 213 voted for certificates. The certificates will be mailed as soon as they can be developed and printed.

A letter has been mailed to all associates of record as of October 24, 1975 to determine how they want their name printed on the certificates.

ADVANCEMENT COMMITTEE

They have compiled a 64 page addition to the Study Guide for Certification. The addition is designed so it can be integrated into your copy of the Study Guide. The addition will contain new questions, bibliography, examples of correspondence with the Board and material on maxillofacial prosthesis. The new material will be included in all Study Guides purchased after December 1975.

The Committee has secured permission to reprint 17 classical articles. These will be published in book form with a hard cover. The cover will have the College seal and title on the front and the title on the back edge so it can be read when on a bookshelf.
