## Avinash Bidra

Dr. Avinash Bidra is a Board Certified Maxillofacial Prosthodontist and Director of the Prosthodontics Residency program at UCONN School of Dental Medicine

Fixed implant-supported prostheses have gained tremendous popularity over the years, especially due to the All-on-Four treatment concept. It is necessary to treat each patient uniquely and avoid using a generic or a similar design of fixed prosthesis for all patients.

This presentation will focus on a systematic method of diagnosis and treatment planning that helps to categorize patients seeking fixed prostheses into 4 classes based on the amount of tissue loss, position of anterior teeth in relation to residual ridge, type of smile, need for lip support and need for gingival prosthesis. Additional practical considerations related to choice of biomaterial, treatment cost, practice overheads, professional and at-home maintenance will be presented.
