Michael Hartman



Dr. Hartman completed his residency training in oral and maxillofacial surgery at the University of Maryland Medical Center in 2008. Since then, he has been in a private practice setting as owner of Hartman Oral and Maxillofacial Surgery.

He has published several papers on dynamic navigation and immediate implant provisionalization techniques. He is also the president and owner of Digital Provisionalization Technologies, a dental laboratory specializing in providing immediate provisional products for surgeon's utilizing the X-Guide Dynamic Navigation system.

This presentation will focus on how digital workflows aid in the planning and execution of dental implant cases. Dynamic navigation dental implant placement will be reviewed and shown how it can be a very versatile and accurate method of implant surgery execution.

The presentation will also show how digital technology allows all members of the patient's dental team (surgeon, restoring doctor, and dental technician) to communicate effectively through all phases of the treatment process ensuring optimal case results.
